#### **STATEMENT OF ISSUE:**

The purpose of this item is to update the Sonoma Mendocino Economic Development District (SMEDD) Board of Directors on the status of Board recruitment efforts in Mendocino and Sonoma counties, provide an update on County processes, respective County reviews, and recommendations for prospective applicants to fill the vacant board positions.

#### **FINANCIAL IMPACTS:**

There are no anticipated financial impacts.

#### **BACKGROUND:**

The SMEDD Board is comprised of nine seats. Three of these seats have been vacant for several months. The recent resignation of Board Member Jon Frech in late September 2023, increased the vacancies to four out of the nine seats. Two of the vacant seats are seats to be appointed by the County of Mendocino; one vacant seat is to be appointed by the County of Sonoma; the remaining vacant seat is a singular At-Large seat to be appointed by the Board of Directors of the SMEDD.

The SMEDD Board has had one previously existing vacant Mendocino County seat, which increased to two vacant Mendocino County seats upon the resignation of Director Frech. At the September 26, 2023, SMEDD Board meeting, the SMEDD Board voted to create an ad hoc committee to review the applications and submit a recommendation to the Mendocino Board of Supervisors for the two vacant positions on the SMEDD Board. At their October 17, 2023 meeting, the Mendocino County Board of Supervisors approved the recommendations and appointed Tim Karas and James Mayfield to serve on the SMEDD Board of Directors. The ad hoc committee did not specify which candidate should be

appointed to complete Jon Fresh's unexpired term. The following appointments and terms were approved by the Board of Supervisor:.

- 1) James M. Mayfield, Director, was appointed to a term ending May 10, 2024
- 2) Dr. Timothy Karas, Director, was appointed to a term ending April 1, 2025

The Board of Supervisors of Mendocino County have filled the two open Mendocino County seats. This leaves two vacant Board seats on the Board of the SMEDD. The purpose of this item is to provide the Board with the opportunity to discuss and take action as may be appropriate to filling the one vacant SMEDD Board seat that must be appointed by the Sonoma County Board of Supervisors, and/or the final vacant Board seat is the At-Large seat that must be appointed by the SMEDD Board of Directors.

#### **DISCUSSION:**

Sonoma County has received three applications for the Sonoma County vacant seat. The Sonoma County Economic Development Board has reviewed these applications and is prepared to bring a recommendation to the Sonoma County Board of Supervisors at the November 28, 2023, County of Sonoma Board Meeting. The description of the candidates and the Sonoma County Economic Development Board's recommendation are below.

The Sonoma County Economic Development Board (EDB) has reviewed three applications for the vacant Sonoma County SMEDD Board seat. The first application is from a person who is a member of the City of Cloverdale City Council and is currently serving as Mayor of the City of Cloverdale. The second application was submitted by the current community development director for the City of Cotati. The third application is from a person who resides in western Sonoma County and is a member of the Lower Russian River Municipal Advisory Council who has extensive experience in project management and working in the technology industry. After review, it is the Sonoma County EDB's recommendation to the Sonoma County Board of Supervisors to appoint the latter of the aforementioned candidates to the SMEDD Board.

The SMEDD Board should discuss a process and timeline for recruiting and filling the final remaining vacant seat, which is the Board's only At-Large seat and the only seat appointed directly by the SMEDD Board. The Board may wish to personally recruit candidates, or have the SMEDD post the vacancy on the SMEDD web page, and use other available opportunities to publicize the vacancy and invite interested individuals to apply. An application could be based upon the existing forms used by the Counties. It could be publicized with an application deadline, as "open until filled"...

In August 2023, the Sonoma Mendocino Economic Development District management team convened available members of the CEDS strategy committee (roster below) to discuss the upcoming process for next year's CEDS update. The update process will be composed of four virtual workshops where CEDS project contacts and regional stakeholders will discuss progress on their listed projects, modifications to strategies, and new opportunities that align with the goals of the CEDS. Each workshop will directly correlate with one of the CEDS' goals: expanding value added sectors, supporting people, increasing equitable community wide prosperity, and resiliency.

### Dry Creek Rancheria Economic Development

In January 2023, SMEDD staff met with David Smith-Ferri from Dry Creek Rancheria to discuss the development of the tribe's economic development strategy. The main topics of discussion were:

- 1) CEDS alignment
- 2) Resiliency strategy
- 3) Additional resources and plans

Staff provided information, technical assistance, and resources for the tribe to reference in their economic development and resiliency strategy. In addition to this planning coordination, two tribal projects listed in the CEDS were identified as priority projects.

In late August, we were informed that the Dry Creek Rancheria Board of Directors approved the new 5-year CEDS for the tribe.

# **Broadband Deployment Planning**

Sonoma and Mendocino Counties have taken significant action to close the internet availability gap by directing staff to research options to expand broadband access. These efforts have been focused on infrastructure development and advancing utilization ("adoption") of existing resources, where barriers to connectivity are related to affordability rather than lack of infrastructure. The Board's actions parallel recent state and federal grant programs that fund and facilitate broadband planning, infrastructure, and adoption.

In the fall of 2022 the County of Sonoma and Mendocino, entered into partnership with Golden State Connect Authority, applied for and each received a ~\$500,000 grant from the California Public Utilities Commission's Local Agency Technical Assistance grant program. The funding is planned to provide a refined high-level broadband network design for unincorporated areas with little or no internet service and low-level, construction-ready design for priority areas. The engineering process is a two-step process: 1) the high-level general design typically maps out the route the fiber network will take, and 2) the low-level design typically shows the fiber to the curb, identifies infrastructure assets like pull boxes, and maps a clear outline for development. These funds will support both types of design. The scope of work for this grant program is anticipated to be completed within 18 months of the grant award (June 2024).

In July and August, Golden State Connect Authority delivered high-level engineering designs for project areas in both Sonoma and Mendocino Counties. Both Counties used the designs and corresponding metrics to select priority project areas to apply for <a href="last mile funding">last mile funding</a> through the California Public Utilities Commission's Federal Funding Account award opportunity. In both counties, the project areas are located directly adjacent to the <a href="state's planned middle mile network">state's planned middle mile network</a>. The County of Mendocino's project area encompasses the coastal region off of state highway one. Sonoma County's selected projects are non-continuous and located in: Jenner, East Santa Rosa, East Cloverdale, and Walsh Landing. Sonoma and Mendocino Counties are working closely together to coordinate plans to expand service to unserved residents.

To further broadband accessibility and advanced adoption, the County of Sonoma has been awarded a \$300,000 grant from the Federal Communications Commission (FCC) Affordable Connectivity Program (ACP). The grant is intended to be used to drive awareness and enrollment in the largest broadband affordability program in the nation's history. Building upon current community partnerships, the FCC has issued grants to support partner organizations nationwide to serve as trusted community messengers about the ACP and to better equip agencies with the funding necessary to pursue innovative outreach strategies to effectively reach historically unserved and underserved communities. During the reporting period, the County engaged private providers to develop outreach partnerships to serve the communities in need. Additionally, outreach has been conducted via radio, social media, email, events, and physical flyers.

### People Places and Issues Outreach

In early April, the SMEDD team conducted in person outreach, interviews, and listening sessions with Mendocino and Sonoma stakeholders. This effort was to increase awareness around SMEDD, the CEDS, and function of economic development districts. The outreach efforts for this tour began in late March. The information was well received from local stakeholders and department heads. From listening to their expertise and needs, we were able to draw the following potential value-adding functions for SMEDD:

- Research, recommend and apply for grant funding and explore Tax Increment Finance tools for infrastructure improvements (such as Climate Resilience Districts; and Enhanced Infrastructure Financing Districts).
- Share the success stories and the lessons learned of our entrepreneurs on multiple websites, such as our cities, counties, Chambers, West Business Development Center, etc., and cultivating a community of entrepreneur mentors.
- Support entrepreneurs in their transition to business and economic development opportunities.
- Explore opportunities and challenges to affect permit process efficiencies for developments that meet specific criteria (e.g. cost of development, number of jobs created, etc.).
- Support efforts to build events and partnerships to attract tourists to Hopland and the inland areas in Mendocino County (Hopland & Willits)
- Support applied entrepreneurship combined with facilities, such as blue economy focused
  makerspace for crab fishermen who are trying to invent lineless traps, and gathering the right
  technical expertise to support them.

- Explore opportunities to improve services for unincorporated areas, including access to "Permit Sonoma" and other services in remote parts of the county.
- Explore the need for an Economic Study to document how agriculture benefits both counties, including employment rates in agriculture and other industries in the region.
- Explore the possibility of transit village uses and development types and densities around SMART stations to better utilize the SMART system, with the goal of encouraging economic development and generating new revenues for SMART through increased ridership.
- Identify opportunities to support SMART grant applications through SMEDD letters of support signed by SMEDD Chair.

# SMEDD Education, Awareness, and Capacity

As stated in the first component of the recovery and resiliency work plan, RGS and SMEDD associates have worked to increase stakeholder understanding, interest and engagement in SMEDD. In early April, the SMEDD team conducted in person outreach, interviews, and listening sessions with Mendocino and Sonoma stakeholders. The outreach efforts for this tour began in late March. The information was well received from local stakeholders and department heads.

The second main goal to accomplish this aspect of the work plan is to Strengthen SMEDD information resources to support resiliency and recovery. During the reporting period, RGS has put in a substantial amount of work to continue developing the district's website, <a href="SMEDD.org">SMEDD.org</a>. Having a web platform and presence allows for the district to effectively reference recovery and resiliency resources such as funding opportunities, local events, partner organizations, and resiliency strategies.

The third main goal to accomplish SMEDD education, awareness, and capacity is to develop productive stakeholder relationships. Though the district has this in some capacity with the CEDS strategy committee, RGS and SMEDD staff are continuously developing these relationships to further recovery and resiliency planning in the region. As outlined below, SMEDD has hosted events such as the business friendliness webinar and regional Ag-Tech innovation brainstorm event aimed to increase industry and economic development/resiliency in the region.

## Recovery and Resiliency Technical Assistance

The RGS and SMEDD associates provided recovery and resiliency technical assistance for Mendocino County and Sonoma County cities through an assessment of business friendliness.

1) **Providing a business friendliness assessment**: The primary objective for the business assessment is to review incentives, programs, communication, processes, fees, timelines, and demonstrated commitment to economic development as a priority, to facilitate existing businesses, business expansion and attraction. On September 28th, SMEDD provided a webinar to City Managers and Economic Development Directors/ Managers outlining the BFC check up assessment tool. The Business Friendly Check-up establishes a baseline of key metrics that city and community leaders can reference to better understand their communities' strengths and weaknesses in this area https://www.smedd.org/business-friendly-check-up-webinar.

# Ag-Tech Innovation Brainstorm Event

The Sonoma Mendocino Economic Development District's Ag-Tech Innovation Brainstorm Event held in Hopland, California, on May 30th aimed to:

- Help stakeholders understand the vision of an AgTech Innovation Hub and its role in supporting economic development in Mendocino and Sonoma.
- Discuss opportunities and challenges in the agriculture and technology sectors and how the Hub can contribute to regional growth and sustainability.
- Identify key stakeholder groups and individuals interested in the Hub's development.
- Determine the level of support among stakeholders for SMEDD to proceed with a Feasibility Study.

#### Meeting Highlights:

- Josh Metz, SMEDD District Manager, presented the Comprehensive Economic Development Strategy (CEDS) and introduced the vision of the AgTech Innovation Hub.
- Lon Hatamiya discussed UC ANR's The VINE program and its relevance to the AgTech Innovation Hub.
- Small group discussions led to the identification of opportunities, projects, partnerships, and challenges related to the Hub.
- Opportunities included providing a physical location for innovation, supporting farmers, and fostering collaboration among stakeholders.
- Partnerships and projects encompassed UC programs, USDA initiatives, local farms, associations, and more.
- Challenges involved ensuring small and medium-sized farms' inclusion, tech's economic viability, job growth, and effective messaging.

# NOAA Coastal Resilience Challenge Regional Working Group

In July and August the Sonoma Mendocino Economic Development District served as the lead convener and facilitator for regional stakeholders to work together on developing a letter of intent to apply for an award from the National Oceanic and Atmospheric Administration for Coastal resilience projects. Below is a summary of the letter resulting from the working group led by SMEDD.

#### **Regional Context:**

The letter describes the challenges faced by coastal communities in Sonoma and Mendocino counties due to climate change, including the erosion of oceanfront lands, damage to kelp and estuarine ecosystems, and the decline of red abalone populations. The decline in these ecosystems has significant economic and cultural implications, and it affects the fisheries, wetlands, and recreational resources in the region.

#### **Resilience Vision:**

Given the context, the SMEDD developed project goals and a vision with the working group to address climate impacts posed by warming waters, rising seas, drought, and increased flooding. The vision includes the following key components:

- 1. Protect, restore, regenerate, propagate, and extend kelp forest refugia.
- 2. Build economic resilience and support a just transition to the changing climate.
- 3. Mitigate estuarine flooding through enhanced ecosystem services.
- 4. Adapt critical harbor infrastructure and public access to rising seas.

#### **Proposed Activities and Outcomes:**

The letter outlines several activities and outcomes associated with the project, including:

Kashia Band of Pomo Indians Conservation Aquaculture and Ocean Ecosystem Restoration: This involves working with various partners to launch a regional kelp forest ecosystem restoration alliance and Tribally operated abalone production and restoration facility. The activities include conservation aquaculture, urchin management, ocean stressor assessment, and construction of green infrastructure aquaculture facilities.

Estuary Resilience and Flood Risk Mitigation: This component focuses on rehabilitating and supporting climate adaptation for estuaries in Sonoma and Mendocino counties. Activities include minimizing flooding, sustaining the role of floods in delivering sediment to marshes, sustaining estuaries as rearing

habitats for juvenile salmonid species, and sustaining the importance of estuaries as bases for recreation and tourism.

North Coast Harbor Economic and Climate Resilience: After restoring the kelp and marine ecosystem, the project aims to strengthen the blue economy through climate-resilient infrastructure and job diversity. This includes upgrading infrastructure at Bodega Bay, such as the ice plant and docks, and replicating native hatchery salmon releases.

Noyo Center for Marine Science: The project supports the construction of the Ocean Science Center Building in Fort Bragg, which will serve as a hub for marine science education and research. The building will include research laboratories, a marine mammal skeleton articulation workshop, and a marine mammal triage center. The Noyo Center for Marine Science engages with the community and aims to address climate change impacts on coastal ecosystems.

SMEDD Program Coordination & Climate Resilience Regional Amplification: SMEDD plays a pivotal role in coordinating and amplifying the regional response to climate threats. This involves convening workshops, compiling progress reports, supporting elected leaders, and developing and maintaining web resources for project teams and the public.

### **Grant Compliance and Oversight**

RGS and SMEDD associates are working together to ensure reporting and administrative compliance are in order. This work is being conducted on the County, State, Federal levels.

Planning Grant No. ED22SEA3020033 = \$210,000 plus a \$210,025.59 match from Mendocino and Sonoma counties

Supplemental Grant No. ED20SEA3070045 = \$400,000 (no match required)

As of August 31, 2023, the \$210,000 portion of the Planning Grant had approximately \$134,497.20 remaining, plus approximately \$13,381.50 in demands (invoices) in process or not yet paid. This grant expires on June 30, 2025.

As of August 31, 2023, the Supplemental Grant had approximately \$53,665.17 remaining, with approximately \$12,084.75 in demands (invoices) in process or not yet paid. This grant expires on June 30, 2024. (A one-year extension of the grant period was requested last spring and granted by the EDA; the June 30, 2024, date reflects the extension.)
