SUBJECT: Election of Board Chair and Vice Chair for Terms of Office from July 2024 through June 2025

STATEMENT OF ISSUE: The purpose of this item is to elect a Chairperson and a Vice Chairperson to serve for the term beginning July 1, 2024, and ending on June 30, 2025.

SUMMARY OF RECOMMENDED ACTION:

Receive nominations for Board members to serve for the term July 1, 2024 to June 30, 2025 in the positions of Chairperson from amongst Mendocino County appointees, and a Vice Chairperson from amongst Sonoma County appointees. After receiving public comments, and deliberating, elect individuals to those positions.

FINANCIAL IMPACTS:

None.

BACKGROUND:

The SMEDD must adhere to numerous and varied laws governing its operations. One such law requires that the SMEDD adopt a set of Bylaws and adhere to them. The current Bylaws were approved by the District's Board of Directors on November 18, 2021. The Bylaws stipulate that the SMEDD shall have a Chair and a Vice Chair, and what their responsibilities and duties are:

ARTICLE VI – ADMINISTRATIVE ROLES

Section 1. The SMEDD Board of Directors shall have a Chair and Vice Chair. The Chair and Vice Chair shall be appointed by SMEDD members by election. Unless sooner replaced by a majority vote of the Board of Directors, the Chair and Vice Chair will serve a term of one year each, with annual elections. The Chair and Vice-Chair shall be elected annually from within the membership of the SMEDD Board of Directors. The sitting Chair and Vice Chair shall at no time represent the same member county. Each role shall rotate between representatives of member counties; no member county shall have a representative as Chair or Vice Chair for more than one consecutive year. They shall be elected beginning on July 1, and continuing to June 30, of the following year, or until their successors have been duly elected.

Section 2. Chair. The Chair shall preside at all meetings of the SMEDD Board of Directors and call for special meetings. The Chair shall carry out the duties listed in the Sonoma County Municipal Advisory Council Policy and Procedures.

Section 3. Vice Chair. In the Chair's absence, the Vice Chair shall assume the Chair's responsibilities. The Vice Chair shall carry out the duties listed in the Sonoma County Municipal Advisory Council Policy and Procedures.

Section 4. Removal of Chair. If the Chair is found to be in violation of any of the conditions for removal outlined in Article IV, Section 2, he or she may be removed by a motion from any member, and by majority vote of the SMEDD Board of Directors, with a quorum being present.

DISCUSSION:

In June 2023, the Board of Directors selected Robin Bartholow to serve as the Chair of the Board of Directors, and Paul Garza to serve as the Vice Chair. Chairperson Bartholow was appointed to the SMEDD Board of Directors by the Sonoma County Board of Supervisors. Vice Chairperson Garza was appointed to the SMEDD Board of Directors by the Mendocino County Board of Supervisors.

The SMEDD Board may choose any member of the Board to serve as its Chairperson as long as the selection adheres to the Bylaws. The Bylaws state: Each role <u>shall rotate</u> between representatives of member counties; no member county shall have a representative as Chair or Vice Chair for more than one consecutive year.

This language requiring an annual rotation between the counties requires the SMEDD Board to choose its new FY 2025 Chair from amongst the Mendocino County Appointees, listed alphabetically:

Paul Garza

Tim Karas

Anna Shaw

The Board would then be required to elect a Vice Chair from the group of appointees from Sonoma County, also listed alphabetically:

Lisa Badenfort

Robin Bartholow

Jeff Kelly

The SMEDD Board of Directors is comprised of nine seats, three of which are vacant.

STATEMENT OF ISSUE: The purpose of this item is for the Sonoma Mendocino Economic Development District (SMEDD) Board of Directors to receive an update on respective regional efforts and progress on the California Jobs First Initiative.

SUMMARY OF RECOMMENDED ACTION:

Receive and file.

FINANCIAL IMPACTS:

There are no anticipated financial impacts for this item.

BACKGROUND:

During the December 8, 2023, February 16, 2024, and April 19, 2024, regular SMEDD Board of Directors meetings, the SMEDD management team provided the Board with an overview and update on the CA Jobs First (previously known as CERF) initiative. The overview and update included the following:

- Regional Representation: Mendocino County is represented by the Redwood Region RISE Coalition. Sonoma County is represented by the Bay Area Jobs First Collaborative.
- Both counties have participated in a solicitation for regional projects for their respective regions to be funded by Catalyst Funds* at \$9 million per region.
- Each region is guided by the principle to create high wage, climate resilient, and sustainable jobs.

*The Catalyst Program reserves funds for each California Jobs First region to bridge the gap between each region's Jobs First Strategy and implementing projects designed to achieve outcomes that align with those strategies. Catalyst funds will support each region's Jobs First Collaborative to invest in sector specific pre-development activities, enabling regions to take projects from exploratory and last-mile to ready-to-go projects that can access local, state, and federal government funds, as well as private and philanthropic investments.

Mendocino County is part of Redwood Region RISE (Resilient Inclusive Sustainable Economy), which is a regional community coalition of close to a thousand members working together to develop a 10-year vision that aims to bring good, sustainable jobs to Tribal Lands, Del Norte, Humboldt, Lake, and Mendocino Counties - through the California Jobs First (previously known as Community Economic Resilience Fund [CERF]) initiative.

The Sonoma County EDB has been working with a subregional round table under the Bay Area Jobs First Collaborative. This subregional roundtable includes Sonoma and Marin Counties. The Subregional roundtable collected projects that meet the fundamental industry and vision priorities. Projects must promote the growth of sustainable, climate forward, high wage, and high growth jobs.

DISCUSSION:

Mendocino County - Redwood Region RISE

The \$9 million in catalyst funds is marked as fully spent within its four-county region. The allocation of how it will be spent is not yet decided. The California Center for Rural Policy (CCRP), Arcata Economic Development Corporation (AEDC), and voting tables will be responsible for allocating funds. The Redwood Region RISE held an in-person meeting for voting block members in late April 2024 in Humboldt. Voting criteria and scoring was workshopped by attendees at this meeting. The County of Mendocino Economic Development Division is a member of the voting block for Redwood Region RISE. Economic Development Division staff participated in the voting selection of projects submitted for development in the region.

There are many Mendocino County engaged actors in the Redwood Region RISE coalition across industry, academia, government, and community-based organizations. Within the SMEDD, Board Members, Mendocino County staff, and the Regional Government Services (RGS) team are engaged in a variety of intersecting ways. This report summarizes work being led by Mendocino County staff, Mary Anne Petrillo as the Blue Economy & Working Lands Sector Table co-leader, and a new Economic Development Finance Working Group being led by the RGS team.

Blue Economy Update:

In pursuit of developing a robust strategy and work plan for the Blue Economy sector, significant strides have been made. Through a combination of virtual and in-person meetings, the Blue Economy Sector Table has grown to over 20 participants, reflecting a diverse array of organizations invested in the region's economic and environmental prosperity.

Achievements:

- 1. **Vision Statement:** The Blue Economy Sector Table has crafted a vision statement: *The Redwood Region is poised to become a global leader in rural regenerative blue economies. To achieve this, we will form collaborative networks of stakeholders to advocate for policy and investment, drive innovative technologies, revitalize infrastructure, create robust and expanded markets, and advance oceanic research.*
- 2. **Strategic Directions:** The Blue Economy Sector Table's strategic directions outline key areas of focus, including advocacy, market expansion, ocean research, and innovation. These directions serve as guiding pillars for future endeavors.

3. **SWOT Analysis:** The Blue Economy Sector Table has conducted a SWOT analysis, identifying strengths, weaknesses, opportunities, and threats within the Blue Economy sector. This analysis will provide valuable insights for informed decision-making and strategic planning.

While the Blue Economy Sector Table acknowledges the challenges posed by climate change and sea-level rise, it remains optimistic about the opportunities for development and innovation within the Blue Economy sector. By leveraging collective expertise and resources, the Blue Economy Sector Table is confident in its ability to overcome these challenges because the local Blue Economy presents a multitude of promising opportunities for sustainable growth. Some highlights are streamlined permitting, efficiently managed dredging, advancements in direct sales and harvesting technologies by fishermen, and the proliferation of online platforms for seafood commerce are just a few examples. Additionally, infrastructure improvements and collaborative research initiatives will further enhance the region's potential for both economic and environmental prosperity.

In conclusion, the Blue Economy Sector Table is progressing in developing its strategy and work plan for the Blue Economy sector in partnership with the Working Lands contingent because it takes a collective effort to create economic prosperity, environmental sustainability, and community resilience. The Blue Economy Sector Table is poised to make meaningful contributions to the advancement of a rural regenerative economy in the California Redwood Region.

Economic Development Finance (EDF) Working Group

Regional Government Services, under a separate service contract with the Arcata Economic Development Corporation (AEDC) serving as the Redwood Region RISE Fiscal Agent, is facilitating the Redwood Region RISE Economic Development Finance (EDF) Working Group. The EDF Working Group is occurring in two phases with Phase 1 undertaken from January 2024 to June 2024, and Phase 2 following directly through December 2024. This expert session focused on New Market Tax Credits (NMTC) and their potential to stimulate investment in economically distressed communities. Attendees received an Overview of New Market Tax Credit 101 followed by a Q&A session and a deep dive into a local North Coast project that utilized NMTC.

Sonoma County - Bay Area Jobs First Collaborative

The Sonoma-Marin Regional Roundtable's facilitators will vote on a set of initial project submissions and bring them to the larger Bay Area Collaborative in the future. The Bay Area Collaborative will bring a set of projects to the State to be funded as pilot projects in this first phase. The Sonoma County EDB submitted a project proposal for \$300,000 to fund an Ag-Tech Innovation Hub Feasibility Study for the North Bay that will leverage the May 2023 SMEDD Ag-Tech Brainstorming Session. The feasibility study would investigate key partnerships, regionally unique focus areas, functions, services, phasing options and location alternatives for a potential North Bay Ag-Tech Innovation Hub. Additionally, the feasibility study will include a pilot project that will analyze the reuse and repurpose of the Manzana facility that is scheduled to be vacated in late fall 2024. The Bay Area Jobs First Collaborative is still considering project funding applications and it is unclear at this time when funding allocations will be made.

STATEMENT OF ISSUE:

The purpose of this item is to update the Sonoma Mendocino Economic Development District (SMEDD) Board of Directors on the status of Board recruitment efforts in Mendocino and Sonoma counties, provide an update on County processes, and recommendations to fill three vacant board positions.

FINANCIAL IMPACTS:

There are no anticipated financial impacts.

BACKGROUND:

The SMEDD Board has nine seats. Three seats are currently vacant. One vacant seat is to be appointed by the County of Mendocino Board of Supervisors; one vacant seat is to be appointed by the County of Sonoma Board of Supervisors; the remaining vacant seat is a singular At-Large seat to be appointed by the Board of Directors of the SMEDD. The purpose of this item is to provide the SMEDD Board with the opportunity to discuss and take action as may be appropriate to filling the two vacant SMEDD Board seats that must be appointed by the respective County Boards of Supervisors, and/or the vacant At-Large seat that must be appointed by the SMEDD Board of Directors.

DISCUSSION:

The County of Sonoma has received four applications for the Sonoma County vacant seat. The Sonoma County Economic Development Board has reviewed these applications and will be recommending to the Sonoma County Board of Supervisors that they take action at their Board of Supervisors meeting on 9/10/2024 to appoint Nicholas Schwanz to the SMEDD Board of Directors. Nicholas Schwanz is a multifaceted professional with expertise in environmental consulting, brand consulting, and marketing consulting. He is also part owner and operator of Solar Punk Farms in Guerneville, California. Nicholas

serves on the Sonoma County Economic Development Board of Directors, and has shown keen interest in climate-forward innovative initiatives such as biomass utilization, ag-tech, and the blue economy.

The County of Mendocino has one vacant Board Member position. Applications are being accepted. Jim Mayfield resigned from the SMEDD Board in April 2024. Mary Anne Petrillo resigned from the SMEDD Board in June 2024. The County Board of Supervisors appointed Anna Shaw to the SMEDD Board in late June 2024. As of this writing, the County of Mendocino has received one application to fill the empty seat. The County's Economic Development Division will be reviewing the application in the near future, and it is expected that it will make a determination regarding recommending the candidate to the County of Mendocino Board of Supervisors for appointment to the SMEDD Board.

The SMEDD has posted *all* the vacancies on the SMEDD web page, and is using other available opportunities to publicize all the vacancies and invite interested individuals to apply. The Board may wish to personally recruit candidates.

If the SMEDD Board would like to recruit with an application process, an application form could be based upon the existing forms used by the Counties. The At-Large vacancy could be publicized either with an application deadline or as "open-until-filled". At this point, vacancies have been publicized without any deadlines for submittals.

The SMEDD Board should discuss a process and timeline for recruiting and filling the vacant At-Large seat, which is the Board's only At-Large seat and the only seat appointed directly by the SMEDD Board.

On behalf of the Sonoma Mendocino Economic Development District (SMEDD), we are pleased to support Sonoma-Marin Area Rail Transit District's (SMART) request for Transit and Intercity Rail Capital Program (TIRCP) funds towards completion of the SMART Rail and Pathway Project.

SMART is experiencing unprecedented ridership growth as the pandemic and fire traumas fade and the new North Bay travel patterns emerge. By 2025, the SMART system will cover 48- of the 70-mile voter approved railroad, with 14 stations and 37 miles of pathway open to the public. SMART is providing more service on both weekdays and weekends than was originally planned and the frequency is attracting new riders every day. When combined with SMART's new short line freight railroad services, the entire system is critical to the economic development of North Bay communities and industries.

We at SMEDD are focused on regional economic investment. Our region across Sonoma-Mendocino Counties recognizes it must diversify its economy to build resilience against downturns in consumer confidence, discretionary spending, and real estate investment. We seek to improve educational access as educational attainment, a traditional strength for the region, has not kept pace with US gains and now trails the national average for postsecondary completion. As an example, the City of Cloverdale has a bachelor's degree rate of 24% compared to Marin County's average of 61% graduate rate. And just as significantly, average earnings are not keeping up with housing costs, creating a disproportionate impact on minority workers.

Completion of the SMART Rail and Pathway system is all about creating healthy and resilient transportation systems in Northern Sonoma County and across the North Bay and North Coast that will facilitate safe access to public education locally and region-wide. We thank you for your favorable consideration of this TIRCP request to match our communities' commitment to a healthier transportation future.
